At the Board of Director's (B.O.D.) meeting July 29, there was a lengthy discussion regarding plans for the construction and layout of the envisioned pistol range. This is a major project and it is hoped it can be completed this year. Also discussed were possible methods of ensuring the properties bordering the Association cannot be sold for residential development. That has been a source for many legal actions across the country that has caused ranges to close.

Association Secretary/Treasurer Brian D'Onofrio has notified the Board he will be resigning in the near future. He plans to move to a more southerly climate for health reasons. He will continue to perform the duties of the office until a replacement is elected or he departs the area, whichever comes first. Also, Board member Jason Epperson has decided to resign due to time commitments elsewhere.

This brings up an important consideration for the membership. The Association Bylaws allow for the replacement of members of the Board who, for whatever reason, cannot fulfill their terms of office. However, no expedited means for the replacement of an officer of the Association exists. Currently, a replacement officer would have to be nominated and elected by the membership in a manner similar to that followed every two years. Any member who has suggestions for addressing this issue should promptly offer his/her suggestion in writing to one of the members of the Board for consideration by the B.O.D.

Comments about the membership meeting and unscheduled BOD meeting that followed:

The club plans a "swap meet (IE: flea market) and shoot sometime in late September.

Steve Hynoski presented –once again— a possible design for the pistol range. It seems likely we will go with a “CONEX box” barrier between the rifle and pistol ranges. Funds have been allocated to purchase two CONEX boxes (shipping containers).

Beginning September 1, “chamber flags” will be required during a “cease fire” at the range. For those not familiar with such items, a brightly-colored “flag” is inserted in the chamber of each firearm on the firing line to easily show no live ammunition is chambered. “Flags” will be fabricated by the club at minimal cost and will be available to members at no charge.

The “security system” (IE: surveillance cameras) has been tabled for the time being. Steel gongs will be placed at 100, 150 and 200 yards for members’ use.

“Cleanup days” have been scheduled for August 24 and September 14. Please come to help if you can.

Member Charles Logue has been appointed to fill the Board position vacated by Jason Epperson. Charlie brings a life-long benefit of experience and will be an asset to the B.O.D.
